According to the AEA Bylaws, ESP (Educational Support Professionals) representation on the AEA Board of Directors shall be at least in proportion with their membership in the association.

ESP members are 20% of the AEA Active Membership. This entitles ESP's to four (4) AEA Board Positions and we currently have one (1) designated position in District II effective August 1, 2010.
